

# Rother District – Council Tax 2019/20

## Introduction

The Council has increased its Council Tax by £5.13 for the 2019/20 financial year which equates to an increase of 2.94% bringing the annual charge to £179.45 for a Band D property. It is expected that this will raise an additional £190,000 for the Council.

There are significant financial pressures on the Council for 2019/20 and beyond. The new Waste Collection and Street Cleaning Contract will cost an additional £1.5 million in a full year over the 2018/19 cost. This reflects the change in this market and the transfer of risk back to the council following the collapse in material prices for recyclates. The Council is responding to these pressures through its Rother 2020 programme which is designed to deliver additional income and savings that will balance the budget by 2023/24. In the interim the Council will use its reserves to best safeguard the essential services it delivers.

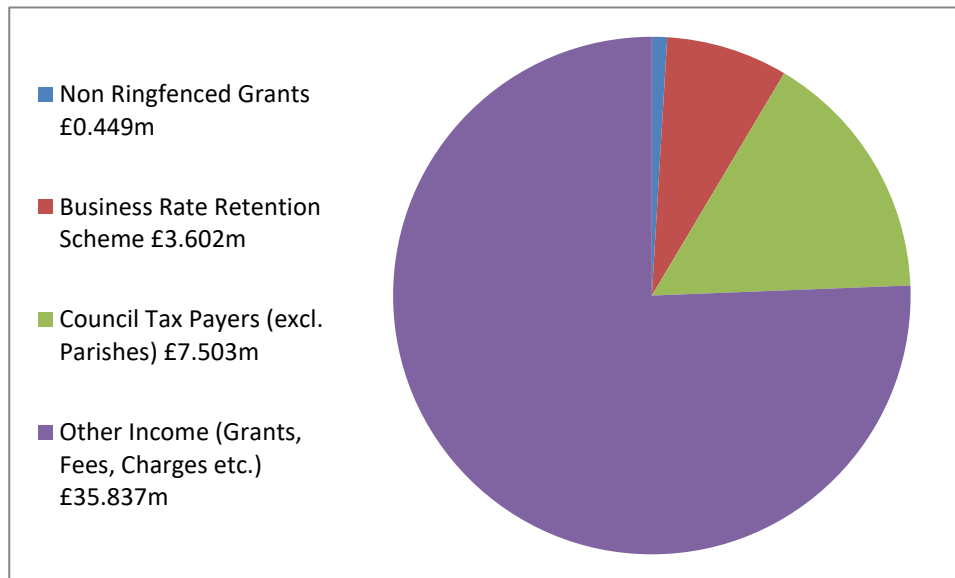

The number of Staff to be employed by the Council in 2019/20 is estimated to be 241 full time equivalents. There is an increase of 2 from 2018/19. A number of posts are funded by external sources.

## National Fraud Initiative – Fair Processing Notice

Rother District Council is participating in an exercise to promote the proper spending of public money.

The Council is required by law to protect the public funds it administers. It may share information provided to it with other bodies responsible for auditing or administering public funds in order to prevent and detect fraud. The Audit Commission currently requires us to participate in its anti-fraud initiative. For the initiative we provide details of trade creditors, taxi drivers, personal alcohol licences, payroll, Council Tax single person discounts and electoral role so that they can be compared to information provided by other public bodies.
